The following is a summary of the August 14, 2006 meeting of the Linn-Mar Board of Directors.

Meeting

Public Hearings were held for construction bids, food service equipment and geothermal systems. No comments were received.

Motions were made to:

- Approve construction bids for Echo Hill and Linn Grove Elementary Schools to Kleiman Construction in the amount of \$18,558,205
- Approve a food service equipment bid for Echo Hill and Linn Grove to Rapids Wholesale for \$567,494
- Approve geothermal system bids for Echo Hill to A-One Geothermal for \$396,000 and Linn Grove to Barker Lemar for \$489,700
- Approve a contract with Edulog for transportation management software, support services and staff training for \$19,600
